CITIZENS' COMMENTS

Ed Semple, 1571 Oak Street: None of this is criticism of anybody or anything. This is just something I think you guys have to think about here. I am going to address this to the service director because it is in his box. I got this letter today from Constellation, which is a company that gives the gas prices, and they are telling me to opt out and I thought it was the city's. Really. I thought it was the city's deal with Constellation. They are telling me that I can opt out from a rate of \$3.99 per mcf. I am going something is wrong here. The city's rate is \$5.99. The city actually negotiated a rate of \$5.99 which is \$2 more than

the Trumbull County aggregate. We can join the Trumbull County aggregate when this is done and everybody in the town can get \$3.99. \$3.99 compared to what we already negotiated at \$5.99. I am not criticizing anybody because it is not fair having not been in the office or sitting there. Who knows what the rate was back then. The rate might have been \$6 or something and \$5.99 might have been a good deal back then, but the city is roped into \$5.99 per mcf for anybody in city that wants to be in the gas aggregate as a Girard citizen but at the same time we could be a part of the Trumbull County aggregate. The guy on the phone was arguing with me. He's telling me what are you talking about, you are in Trumbull County. You get the Trumbull County rate. No. I didn't take city's aggregate because I found one less than \$5.99 but I told him his person told me I couldn't have it and then they finally figured it out. Girard had an aggregate separate from the county. So, I am asking the administration to seriously look at that because when that contract is up, when that aggregate is up you guys can do it. You can get in the Trumbull County aggregate. Same company \$2 more per mcf. **President of Council Paolone:** And Mr. Semple if you are over 65 you get \$3.89 because I get it for \$3.89. I don't think you're over 65 but if you were then it would be \$3.89. It is actually \$.10 cheaper if you are over 65. It has been that way for about a year. I wish you would have called me. There was discussion between Mr. Semple and Mr. Paolone.

Greg Greathouse: I am the 3rd ward councilperson in Warren, Ohio. I am also the finance committee chairperson and the utilities committee chairperson. I just wanted to let Girard know that the City of Warren has taken the first step into acquiring and converting the Ohio Edison Warren streetlights to leds. Fuel efficient. It will cost us about \$2.8 million to convert it once we get done with the six rounds of bare knuckle boxing involved with taking those away from Ohio Edison. We have just taken our first step. It is an audit. We actually have boots on the ground from a company in San Francisco. They are walking the entire City of Warren counting the streetlights, taking 20 data points at each light and then that will give us an accurate count on the number of lights that we have. I worked for Ohio Edison for 30 years and we never counted the lights in my 30 years. I've been gone 20 and I know they haven't done it in the last 20. They don't know how many lights they have in the city. I know how many lights they bill us for, but the company that we have contracted with says they normally find a 10% discrepancy between what you are being billed for and what is actually there. I'd invite, I'd really like to sit down and talk with perhaps the mayor and perhaps the utility committee chairperson. Paolone: That would be Sam sitting right in front of you. I'd be happy to me with you afterwards and give you the gory details. Paolone: We need your name and address. Greathouse: I'm sorry. I live at 378 Bonnie Brae NE in Warren, Ohio. Paolone: Thank you for coming.

MAYOR MARK ZUPPO PRESENT

Mayor Zuppo: I apologize for being late. Double overtime. Just a couple of things. I am going to be asking for the water policy ordinance which the law director researched and found for me. I'll be asking for that to be brought to the table for amendment. We have contracted with KO Consulting for grant writing services for \$3,000 a month. We have met with them a few times, talked to the mayor of Campbell, Brian Tedesco, talked to the mayor of Struthers, Cat Miller, talked to Laura Carey at the Multi Generational Center they have all utilized this service from this company and they all speak very highly of them. We have checked all of their references. Almost guarantee that that money will be worth 10 times that in grants. So we already have them working on some stuff and we are working on prioritizing those things right now. I wanted to mention that the safety service director and I went to the new health department last week. We met with them for a couple of hours. Frank laid out the red carpet for us and

we think that there are services that we have at our disposal that we haven't utilized to the fullest extent and we have already reaped some benefits from those meetings and working on some blighted homes, water shutoffs, things of that nature. I wanted to announce tonight that we are going to start an employee of the month program. We kicked it around with some of the employees, some of the department heads. As our recently deceased Willie Constantino was one of the great city employees ever. He did his work impeccably, cleaned up his work, always had a smile on his face, was civic minded. We want to call the award the Willie Constantino employee of the month award. We are going to be asking for the seasonal workers for recreation this evening. We are going to be asking for, let's just call it the Buddy Bornemiss ordinance for recreation director which is what Mr. Cardiero should actually be under that. We are going to ask for that to be brought back for amendment next meeting. We are going to ask for, we'll call it the Randy Weibel ordinance, the building and grounds director ordinance to be brought back for amendment at the next meeting as well. Pending your questions that concludes my report.

SAFETY/SERVICE DIRECTOR

SALVATORE PONZIO

PRESENT

Salvatore Ponzio: First thing I want to congratulate Mike Scoville. He is going to be the new superintendent at the wastewater treatment plant. He accepted the job. He is going to start February 18th this month. Mike has been a long-time employee. He has all of the licenses that are required to run the plant efficiently and a lot of knowledge from being there a long time. He is going to be a real asset for us and he has been. Mark and I have a meeting with the civil service commission tomorrow conducting oral interviews for the police department. The police chief tells us he needs at least 3 new officers. He is running short. Mandating overtime. We just had one police officer resign and get a job with Youngstown, so we lost another one. Hopefully, we can take care of that for John as soon as possible. We also got a call about a week and a half, two weeks ago from the American Legion. They have some members that are handicap and they asked us to help them with some handicap parking on High Street where they can enter without steps at the back of the building there. So, with the help of the police chief, fire chief, and Tommy Watts at the street department we reviewed it, Brian made sure I was doing everything legal, it took awhile to do that to make three handicap parking places there. So we've already last week when the weather was nice Tommy got the signs in and made the markings. There was a fire hydrant there so they marked that also because you can't park there. There's a sign for that too. The American Legion was very grateful and we told them anything we can do to help we would always be willing to help them. That's all I have today.

Well council can create the positions I am still a little unclear of having job description and stuff having two separate directors in the same department. I mean you can have the two full time employees but typically there would only be one non-union director in the department. I'm not sure how the second position would be handled or what the job description would be for that. It would have to be hashed out before we prepare the legislation for next week.

I printed out another report that shows the total tax collected for like the last ten years based on the type of tax that came from withholding, net profit. You can take a look at it. If you have any questions let me know. It just gives you a little bit of information. I filed 2023 tax certification with the State of Ohio today so that is done annually online so I did that.
