REPORT OF OFFICERS AND DIRECTORS OF THE CITY

MAYOR MARK ZUPPO PRESENT

Mayor Zuppo: Real brief report this evening. Our website. We continue to tweak our website, cityofgirardoh.gov. We will be posting council minutes. Monica, when did we decide we will be able to post those by? Monica: I sent this year's to Erik today so as soon as he gets to that they will be up. I am not sure when that will be. Mayor: So we will be posting the minutes on our website. We are going to be adding to our artificial intelligence lady, Gabby, to her knowledge base so that you will be able to ask more and more questions and quick answers. As far as recreation, I think you might have noticed that Tod Park continues to get upgrades. The roof on the bocce courts and the gazebo all redone and looking great. Mike and his staff continue to be hardworking and getting the job done in the city in our parks. The public hearing that we had for the zone change was well, there were a lot of people here. There were a lot of comments made but in the end everybody kinda agreed to it so now it is in council's hands. Council will be advising you of your duties shortly. As I mentioned earlier, we have a new traffic officer who will be getting the job tomorrow. We will be getting together talking about getting our parking situations in town squared away. We are parking all over the place. We are parking on the corners, parking next to hydrants. If there is a safety issue I don't need our fire chief to have to run to a fire and find that a hydrant

is blocked because somebody is having a party at their house. We are going to give people warnings. We are not going to come out and club them over the head. We are going to give them warnings, but you are going to get one warning and then you are going to get ticketed. He will also be assigned to the speed camera, etc. Any accident that occurs in the city the traffic officer will get called. I had a long conversation with the police chief about it and we think it is really needed. Without further ado, that concludes my report.

COMMENTS:

Moliterno: I would say mayor, I see it pop up on Facebook from time to time about updating the general public as to the website and some of the other things, activities, I think that is great. A very positive thing to do for the city. Continue that line of communication. **Mayor:** Thank you. I would also like to point out that we started a podcast, the mayor's podcast, that will be coming from TCTC sometime probably, we talked about starting it last month, but he had some technical issues out at TCTC, Mr. Doran, but I will be starting that either late July or early August. Much more communication. I am all about getting the word out to everybody.

SAFETY SERVICE DIRECTOR SALVATORE PONZIO PRESENT

Mr. Ponzio: I have a couple of things. First of all, regarding the legislation about paving today, I want council to know our engineers are ready to put the bids out as soon as we get the approval to do so with the goal being to have the roads that we can afford to pave done before, while they are still making asphalt. Also, the mayor just informed me that we are going to meet with Eastgate tomorrow and KO Consulting to research some funding opportunities for a traffic light signal study throughout the community. I know Tom wanted the one on Trumbull taken care of so we are going to do a study to see which lights are warranted and which ones aren't warranted and, hopefully, have all of the lights on 422 be organized so we're not, I think they need to be reset so it helps traffic flow in the community. It shouldn't have one light and then go to the next red light and then the next red light, so we have gotten a lot of complaints about that. So, we are going to see if they can do something to help us out. I will let Tom know what we find out at the meeting tomorrow. One other related thing is legislation is on the table today, with the help of the law director and the fire chief I was able to issue a nuisance abatement for 344 E. Wilson for the koi pond where the child almost drowned. I am happy to report that he did comply with the nuisance abatement and it is filled in. He is buying grass and now we are going to have an ordinance for this and hopefully that will never happen in Girard again. That concludes my report Mr. Chairman.

LAW DIRECTOR BRIAN KREN PRESENT

Attorney Kren: The paperwork has been submitted to the sheriff's office to issue the sheriff's deed for the abatement at TK Charles Property that we had tore down. I am expecting that any day now to get recorded. I will let the administration know as soon as I find out when the paperwork makes it's way through the county so that the city has title to that property. As to the correspondence about the zone change. All zone changes must go through council as opposed to variances which don't have to come to council. Council needs to set a public hearing at least 30 days out before they could vote on either approving the recommendation for the amendment or not. That is all I have.

The the cost to the city will be roughly \$1600.
