Mr. Ponzio: My first thing on the agenda I'm crossing out because it is about paving. Second, I just want to say that we had a very productive meeting of the Wellman Theater Committee with the engineers and Keith and Lily were there. I think mostly what we did, we have a much clearer path moving forward and a more general understanding of how things need to proceed. I think that was productive. I'm going to leave that to Lily to discuss during her report. There's also an ordinance, 3 of them, for the part time firefighters. All it is is changing scheduling hours. They will not be eligible for healthcare still, but it makes the fire chief able to schedule better than 29 hours a week limit. So, with 120 hours a month limit we will have full shifts on all turns then so that is going to help him out. If you can pass that today that would be great. The mayor and zoning asked me to ask for an amendment for ordinance 7726-10. That is the ordinance that deals with recreational vehicles on residential areas. So what they are asking for is to move the end deadline only from October 1st to October 31st. When I asked for rational, they sald the last so many years the weather has been so much nicer in Fall people have be using those vehicles longer and zoning is have a very difficult time enforcing this ordinance. Some things have gone to court and haven't been completed. Councilwoman Martuccio: What was that number? Palone: 7726-10. Moliterno: That means that we ask for it to be pulled? There was further discussion on how to handle this amendment. Paolone: You have to ask for it to be put on the agenda for the next meeting. Remind us under new legislation. One of us will ask for it.
