AN ORDINANCE CREATING THE POSITION OF CEMETERY FOREMAN FOR THE CITY OF GIRARD, OHIO, AND DECLARING AN EMERGENCY.

52-92 **THIRD READING**
AN ORDINANCE AUTHORIZING THE SAFETY-SERVICE DIRECTOR OF THE CITY OF GIRARD, OHIO TO PREPARE AND SUBMIT AN APPLICATION TO THE EASTGATE REGIONAL COUNCIL OF GOVERNMENTS FOR SURFACE TRANSPORTATION BLOCK GRANT (STBG) FUNDING FOR THE RESURFACING OF HIGHLAND AVENUE FROM MORRIS AVENUE TO CHURCHILL ROAD AND DECLARING AN EMERGENCY.
